

## FIRST AMENDMENT TO BLOOMBERG SCHEDULE OF SERVICES

This first amendment (the "First Amendment") to the Bloomberg Schedule of Services under Order No. 24972204, replaced by Order No. 25175052, is by and between **FINANCIERA NACIONAL DE DESARROLLO AGROPECUARIO, RURAL, FORESTAL Y PESQUERO (FND)** ("SR") and **Bloomberg Finance L.P.**, a Delaware limited partnership ("SP"). Capitalized terms used herein but not otherwise defined shall have the meanings set forth in the Agreement.

For good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree to vary the terms of the Schedule as follows:

- Terms and Conditions:** The following is hereby added under Terms and Conditions "Notwithstanding anything to the contrary in the Schedule, the next renewal for the following Subscription IDs (the "SIDs") (1) SID 8884775 shall commence on November 12, 2021, (2) SID 8901594 shall commence on November 19, 2021, and (3) SID 8919286 shall commence on November 27, 2021, with all three ending on December 31, 2021 ("Renewal Term")", provided however, if SR terminates any Services subscribed for under this Schedule during the current term ending on December 31, 2021, SR's renewals will revert to standard 1 year auto-renewals, and SR shall be responsible for (x) payment of any applicable charges that would have otherwise been due and (y) the applicable charges under section 3 of the Agreement (including the termination charge described therein). After the Renewal Term, the Schedule Term shall revert back to the terms on Paragraph 2(b) of the Schedule, automatically renewing for successive one year periods. "

Each party represents that the person signing on its behalf has the legal right and authority to execute, enter into and bind such party to the commitments and obligations set forth herein.

Except as set forth in this First Amendment, the Schedule shall remain unchanged and in full force and effect. In the event of a conflict between the terms of this First Amendment and the terms of the Schedule, the terms of this First Amendment shall prevail.
